OFFICIAL BRC CORVETTE RAFFLE RULES

The Batavia Rotary Club ("BRC") Corvette Raffle ("Raffle") begins on June 19, 2023 and ends on November 18, 2023 ("Raffle Period"). Raffle is licensed by the City of Batavia, IL. The raffle drawing is November 18,2023 at approximately 5:00 PM - 5:45 PM (CST) at K.Hollis Jewelers, Boutique, & Wine Bar, 2030 Main Street, Batavia, IL 60510. The grand prize is the choice of a Base 2024 Corvette (1LT) Coupe (INVOICE PRICE) or \$50,000 cash. Delivery of the vehicle is from Bob Jass Chevrolet, 300 S. Main St. Elburn, IL. Eight cash prizes will also be awarded at \$500 each (including 3 Early Bird drawings). All proceeds shall benefit local charities, and Rotary International Programs. A maximum of 1200 tickets will be sold. Tickets may be purchased by mail, internet (bataviarotarycharities.com) or from BRC members. A list of all prize winners will be posted on the raffle website on or about November 20th, 2023. Funds for the 2023 Corvette Raffle will go towards the purchase of a 2024 Corvette from Bob Jass Chevrolet. The Raffle is Void where prohibited by law. Official drawing date and location subject to change. (All Winners are responsible for all Federal, State and Local Taxes, if any, associated with Prize received. Taxes will be withheld if the grand prize winner chooses the cash award.)

1. RAFFLE ELIGIBILITY.

The Raffle is open to all persons age 18 and over who have U.S. or Canadian addresses. Please check your state rules on purchasing a raffle ticket. Raffle tickets ("Tickets") are one hundred (\$100) dollars each. The ticket purchase price does not qualify as a charitable contribution. Personal checks should be made out to "Batavia Rotary Club." Internet and mailed entries and payment must be received by BRC no later than 6 PM (CST) on November 17th, 2023. All entries must include payment by personal check, bank check, money order or credit card (Visa, MasterCard and Discover Card) payment. For credit card purchases, the Winners must provide the full name, billing address and telephone number of the cardholder and the credit card number and expiration date per the requested information on the entry form. Any Entry Form and payment received after 1200 tickets have been sold, will be returned. No other refunds will be made, except as otherwise determined by BRC in its sole discretion. Subject to availability, Winners may purchase as many Tickets as they wish. BRC reserves the right to disqualify false entries or entries suspected of being false, and any illegible, defective, incomplete or physically altered Entry Forms and entries that do not include valid or complete payment. BRC is not responsible for printing errors in any Raffle-related material, or for lost, late, misdirected or non-delivered mail or corrupt internet messages, or any other failure to receive orders or deliver receipts prior to the drawing deadlines. All entries become the property of BRC and will not be returned. BRC reserves the right to withdraw this offer at anytime.

3. PRIZES.

Grand Prize: The Grand Prize Selected Winner will have the choice of a Base 2024 Corvette (1LT) Coupe (Grand Prize) or a \$50,000 cash prize ("Cash Grand Prize"). The election of this prize choice must be submitted in writing to BRC no later than twenty (20) days after the Grand Prize drawing. If the Grand Prize Selected Winner fails to affirmatively elect to receive a vehicle within this time period, he or she will be deemed to have elected to receive the Cash Grand Prize. If the Grand Prize Selected Winner elects to receive a vehicle, he or she must make a payment of tax, equivalent to the required tax withholding based on the fair market value of the Vehicle, as required by the Internal Revenue Service. BRC will issue a 1099MISC for the fair market value. The Grand Prize Selected Winner may select additional options of the Vehicle, but BRC will only pay the base cost as determined by Bob Jass Chevrolet as referenced above directly to the dealer and the Grand Prize Selected Winner assumes

any additional expense. If the Grand Prize Selected Winner fails to order the Vehicle and pay for any selected options within thirty (30) days of the Notification, he or she will have been deemed to have elected to receive the Cash Grand Prize. The Vehicle is provided "as is" with no guarantees or warranties from BRC. The Vehicle is untitled and provided as New Condition by the Dealership with acceptable delivery mileage and will be supplied with the manufacturer's warranty and other guarantees as provided by the manufacturer. If any Selected Winner cannot be located or fails to return attempts to contact him or her within fifteen (15) days after BRC's first attempt to contact him or her, such Selected Winner will be deemed to have forfeited his or her prize. Another Selected Winner will not be drawn. The prize may be forfeited if Selected Winner(s): cannot be reached or cannot accept or receive the prize for any reason. Winners grant permission for the use of their names, photographs/likenesses for advertising and promotion for this and similar promotions without compensation, unless prohibited by law.

5. RULES & LIABILITIES.

The Raffle is subject to these Official Rules. These Official Rules shall not be changed by any oral statement made by any person or otherwise acting on behalf of BRC. By participating, Winners agree to ALL of the following: 1. To be bound by these complete Official Rules and the decisions of BRC shall be final and binding. 2. To waive any right to claim ambiguity in the Raffle or these Official Rules, except where prohibited by law. 3. By accepting a prize, Selected Winner agrees to release BRC, its officers, directors, employees, volunteers, members, representatives and agents, and any person or entity associated with the production, judging, or administration of the Raffle (collectively, the "Releases") from and against any claims, damages, disability, attorneys' fees, and costs of litigation and settlement, as well as any liability due to any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from redemption, acceptance, possession, ownership, misuse or use of any prize or participation in any Raffle-related activity or participation in this Raffle. 4.
